### Meaning of accredited test and accreditation

The Performance Lab is accredited by ACCREDIA with accreditation number **1762L** for the tests listed in the official list available in our testing laboratory or at ACCREDIA. The accredited tests available on the websites: [www.accredia.it](http://www.accredia.it) or <https://www.icaspa.com/it/it/performance-lab> or <http://www.performancelab.tech/> are duly distinguished from non-accredited tests in the Offer, in the Test Report and in the Test and Method List available in our testing laboratory.

The accreditation and the following agreement with ACCREDIA imply that this body has approved and verifies the "...technical and organizational requirements of our testing laboratory so that measurement standards, reliability and availability of the procedures used, adequate instrumentation, staff expertise, as well as impartiality of the staff in charge of testing and of the evaluation given by our laboratory are guaranteed, according to UNI CEI EN ISO/IEC 17025:2018 standard and ACCREDIA provisions" (source: [www.accredia.it](http://www.accredia.it)).

The Test Report with ACCREDIA trademark (if containing accredited tests), issued by our testing laboratory, does not imply the approval or certification of the product sent for testing.

Set up following the merger of SINAL (Italian Accreditation System for Testing Laboratories) and SINCERT (Italian Accreditation System for Certification and Inspection Bodies) as a non-profit association, ACCREDIA (Italian Accreditation Body) is the only domestic body appointed by the Italian government on 22 December 2009 to carry out the accreditation process.

In Italy, ACCREDIA verifies the technical and organizational competence of testing laboratories in carrying out testing and/or calibration. These skills are periodically verified through spot checks on tests subject to accreditation and on quality management system. ACCREDIA accreditation refers to those tests which the testing laboratory has submitted for accreditation and therefore does not include other services such as counseling, and/or opinions based on the results of the tests.

Our testing laboratory is authorized to use ACCREDIA trademark in the cases and in accordance with the terms provided for by ACCREDIA. In particular, the trademark will be reproduced on Test Reports only in the case they include at least one accredited test". The trademark or any reference to the accreditation shall not be used by customers in the documentation concerning the products, or be reproduced on products. However, a copy of the Test Report can be attached to the products.

Our testing laboratory has the duty to make its customers aware of these limitations and to monitor their application.

Finally, the trademark or any reference to the accreditation should not be used in any manner that might give the impression that ACCREDIA acknowledges liability for the result of the tests or for any opinion and interpretation that may arise or that ACCREDIA gives approval to a sample test or to a product.
